# Geological Society of America Member (Individual) Subscriptions to Online Journals

### In brief, the following applies to your subscription to GSA online journals:

- 1. The Geological Society of America grants a non-exclusive, non-transferable license to the subscriber for limited online access to the GSA online journals, including each online journal for which the subscriber maintains a current subscription. This grant extends only to the subscriber and may not be transferred to, or extended to, others.
- 2. The subscriber agrees to maintain their username and password as personal and confidential information. The unauthorized use of the subscriber's username and password for access to the GSA online journals is a breach of this agreement and a violation of GSA's copyrights.
- 3. The subscriber may download, save, or print one hard copy of the text, search results, or other information from the GSA online journal solely for the private use or research of the subscriber.
- 4. The subscriber has online access to the journals and their archives as long as the subscriber has a paid subscription (print or online) or an active Student, Early Career Professional, or Teacher membership.
- 5. Using your password and username to access the GSA online journals will constitute acceptance of all of the terms and conditions of this agreement. See below for a complete listing of terms and conditions.

## GEOLOGICAL SOCIETY OF AMERICA ONLINE JOURNAL MEMBER LICENSE

**1. BY ACCEPTING THIS LICENSE AGREEMENT** ("AGREEMENT"), the individual Geological Society of America member ("Subscriber" or "you") agrees to the terms and conditions set forth in this Agreement. In turn, the Geological Society of America ("GSA") grants the Subscriber the right to access GSA's online versions of the journals renewed by the Subscriber subject to the following terms and conditions.

GSA's Online Journals are the electronic versions of those journals to which the Subscriber maintains a valid print and/or online subscription. You have already indicated to GSA by your online renewal registration and prepayment your current journal subscriptions for the Online Journals. The span of articles currently available online is indicated below. The GSA Online Journal Service ("GSAOJS") includes the Online Journals and newsletter, *GSA Today*, as listed below and any additional materials that GSA may choose to provide.

#### **TERMS AND CONDITIONS**

2. Authorized User, Subscriber ID and Password. GSA grants a non-exclusive, non-transferable

license to the Subscriber for online access to the GSAOJS, including each Online Journal for which the Subscriber maintains a current subscription to the online version thereof. This grant extends only to the Subscriber and may not be transferred to, or extended to, others.

You agree to maintain your Subscriber ID and password as personal and confidential information. The unauthorized use of the Subscriber's ID and password for access to the Online Journals, with or without the Subscriber's knowledge, is a breach of this Agreement and a violation of GSA's copyrights. The Subscriber is responsible for undertaking reasonable measures to prevent access by unauthorized persons to its ID and password. The Subscriber shall be responsible for storage, display, access control, and security measures.

**3. Permitted Use.** The Subscriber is permitted online access to the GSAOJS and the Online Journals indicated in Section 1, and may download, save, or print one hard copy of the text, search results, or other information from the GSAOJS solely for the private use or research of the Subscriber. The Subscriber may only use this online access in a way that conforms to all-applicable laws and regulations.

GSA grants the Subscriber permission to use brief excerpts, figures, and tables from the content of Online Journal articles with the appropriate credit of the source, and to copy and transmit content from individual Online Journal articles with third parties to the same extent as the print edition of the Online Journal or as permitted under the fair use provisions of the U.S. Copyright Act, subject to the restrictions, if any, set forth in any article included in an Online Journal. The Subscriber agrees that the GSAOJS will only be used on one computer workstation at a time. The Subscriber specifically agrees that use by the Subscriber other than indicated above is a violation of the terms of this Agreement.

**4. Prohibited Uses.** Altering, recompiling, copying, reselling, redistributing, publishing or republishing (beyond the brief excerpts, figures and tables permitted under Section 4) of any journal text, output, search results, or other information from the Online Journals, including without limitation, copyright, trade secret, proprietary and/or other legal notices contained therein, in any form or medium is prohibited. Systematic downloading, service bureau redistribution services, printing for fee-for-service purposes and/or the making of print or electronic copies for transmission to nonsubscribers or non-subscribing institutions (such as in interlibrary loan) are prohibited. Downloading portions of the GSAOJS or Online Journals for the purpose of creating pre-loaded local copies (not including transient, dynamic caches of individually requested material) for redistribution is prohibited. The GSAOJS cannot be used on more than one computer workstation at a time. All rights not expressly granted are reserved to GSA. The Subscriber agrees that he/she will not circumvent GSA's access control systems.

GSA shall not be required to distribute, and Subscriber shall not redistribute, the GSAOJS or Online Journals to a country where the export thereof is prohibited by U.S. law or regulation.

- **5. Duration of Agreement.** Using your password and username to access the GSAOJS or Online Journals will constitute acceptance of all of the terms and conditions of this agreement and will remain in effect while the Subscriber maintains a current paid online subscription to the Online Journal(s). This Agreement will terminate:
- a. Subject to (b.) and (c.) below, if the online subscription lapses (termination is effective at the end of the paid subscription period).
- b. Following thirty (30) days' prior written notice that any term or condition of this Agreement has been violated for any reason, knowingly or unknowingly, provided that the violation is not remedied immediately, but no later than ten (10) days upon notification. The foregoing notwithstanding, GSA reserves the right to suspend access to GSAOJS in the event the Subscriber upon receiving

written notice that Subscriber is in breach of this Agreement and Subscriber has not immediately taken reasonable steps to cure such breach. GSA agrees to notify the Subscriber as soon as possible, usually within three (3) days of any such suspension of access to GSAOJS, by sending an e-mail to the Subscriber's address.

- c. Following thirty (30) days' prior written notice by GSA of any change in the terms of this Agreement, receipt by GSA of notice from the Subscriber in writing, e-mail or fax that the Subscriber does not accept such change(s). Subscriber agrees that in the absence of any objection to such change(s), GSA's new terms shall apply. This Agreement shall renew automatically for the term of any print and online subscription upon receipt by GSA of payment for the subscriptions.
- **6. Copyright.** The GSAOJS and Online Journals and their contents, including abstracts, are copyrighted by the GSA under the Copyright Law of the US (Title 17, U.S. Code), which is party to both the Universal Copyright Convention and the Berne Copyright Convention, and are subject to all applicable copyright, database protection and other rights of GSA as copyright owner and publisher under the laws of the United States and other countries. Subscriber agrees not to remove or obscure copyright notices. This license grants no copyright or ownership interests to Subscriber for any of the material and proprietary information referred herein belonging to GSA.
- **7. Failure of Performance.** Following online access approval, the Subscriber will be permitted to attempt online access to the GSAOJS at any time. GSA, however, will not be liable for any delay, downtime, transmission error, software or equipment incompatibilities, force majeure or other failure of performance whether such failure of performance is caused by GSA or an outside service provider contracted with by GSA. GSA will use commercially reasonable efforts to correct any material performance problem brought to its attention and may suspend performance pending such correction. GSA's responsibility to the Subscriber does not extend beyond such efforts.
- **8.** Official Version of Record. GSA will use commercially reasonable efforts to ensure that the Online Journals correspond in content with the related print journal but GSA does not guarantee that they do. In the event of any discrepancy between the print and online version, the online version of the journal will be the official version of record.
- **9. GSAOJS Statistics and Privacy of Authorized User Information.** GSA will collect and track usage statistics on GSAOJS. GSA recognizes the importance of protecting the privacy of Subscriber information collected on GSAOJS. GSA will not collect personally identifiable information unless the information is willingly provided to GSA by Subscriber. GSA will only use this information internally or to notify users of GSAOJS regarding content updates or for marketing purposes.
- 10. Disclaimer of Warranties; Limitation of Liability; Indemnification. GSA warrants that it is entitled to grant the Subscriber the licenses granted in this Agreement. EXCEPT AS SET FORTH IN THE PRECEDING SENTENCE, THE GSAOJS AND ONLINE JOURNALS ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF PERFORMANCE OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR WARRANTIES AS TO THE ACCURACY OR COMPLETENESS OF THE ONLINE JOURNALS. NEITHER THE GSA, NOR ANY INDIVIDUAL OR OTHER PARTY INVOLVED IN THE CREATION, PRODUCTION OR DELIVERY OF THE GSAOJS AND ONLINE JOURNALS SHALL BE LIABLE FOR ANY DAMAGES THAT RESULT FROM SUBSCRIBER'S USE OF THE GSAOJS AND ONLINE JOURNALS SUCH AS LOST TIME, LOST PROFITS, COMPUTER PROBLEMS, OR OTHER SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, REGARDLESS OF WHETHER SUCH DAMAGES ARE FORESEEABLE OR WHETHER SUCH DAMAGES ARE DEEMED TO RESULT FROM THE FAILURE OR INADEQUACY OF ANY EXCLUSIVE OR OTHER REMEDY. In no case shall Subscriber's liability exceed the amount of license fees paid during the 12-month period preceding any claim or notification of damages. The

foregoing limitation of liability and exclusion of certain damages shall apply regardless of the success or effectiveness of other remedies. No claim may be made against GSA unless suit is filed thereon within one (1) year after the event-giving rise to the claim.

The Subscriber assumes sole responsibility for all use of the GSAOJS and the Online Journals by the Subscriber. In the event of a breach of this Agreement by the Subscriber, the Subscriber agrees to indemnify and hold GSA harmless from and against any and all claims, liabilities, damages, expenses (including attorneys' fees for the enforcement of this Agreement and otherwise for GSA's defense of indemnified claims), losses and threatened losses arising from, or in connection with, that breach, including without limitation, claims of unauthorized use.

11. General Provisions. The Subscriber may not assign or transfer its rights or obligations under this Agreement except with the prior written consent of GSA. This Agreement shall be construed and interpreted pursuant to the laws of the State of Colorado applicable to contracts wholly entered into and performed in the State of Colorado, excluding that body of law dealing with conflict of laws. Any legal action, suit or proceeding arising out of or relating to this Agreement or the breach thereof shall be instituted in a state court of competent jurisdiction in Boulder County in the State of Colorado or in a federal court of competent jurisdiction in Denver County in the State of Colorado and each party hereby consents and submits to the personal jurisdiction of such court, waives any objection to venue in such court and consents to the service of process by registered or certified mail, return receipt requested, at the last known address of such party.

The Subscriber must pay any taxes, other than taxes on GSA's net income, arising out of the Subscriber's use of the Online Journals and/or the rights granted under this Agreement. The provisions of Sections 2, 3, 4, 6, 8, 9, 10, and 11 hereof shall survive any expiration or termination of this Agreement.

This Agreement constitutes the complete understanding of the parties and supersedes all prior oral and written understandings between the parties with respect to the subject matter of this Agreement. No modification, amendment or waiver of any provisions shall be valid unless in writing and signed by both parties. Any waiver in one or more instances by either of the parties of any breach by the other of any terms or provisions contained in this Agreement shall not be considered a waiver of any succeeding or preceding breach.
